PART 1 OVERVIEW

The City of Swan is seeking Expressions of Interest from a range of West Australian creatives including but not limited to: authors, poets, playwrights, visual artists, song writers & musicians to participate in the City of Swan's inaugural Creative Writing Residency. Creatives of all career levels (whether community, amateur, emerging or professional) are encouraged to apply.

The panel will shortlist six (6) creatives for this commission, with each creative offered free use of the historic Courtyard Studio in Midland, WA, a detached 37.5sqm building for two (2) months each in 2024.

During the residency period, creatives will be required to facilitate four (4) community programs as well as produce a work of creative writing inspired by their experience of Midland. The work produced should be relative to the creative's own field and may be a song, a short story, a play, a poem or a text-based artwork.

The commissioned work will be collated with documentation of workshops, conversations with the creatives and other outcomes of the residency before being published in 2025.

ARTWORK LOCATION

The City of Swan, located north east of Perth, is the largest local government by land size in the Perth metropolitan area, and has one of the fastest growing populations.

The Whadjuk people of the Noongar Nation have been the traditional custodians of the land for more than 40,000 years. The Derbal Yerrigan (Swan River) holds enormous cultural significance for the Noongar people. The City is also rich in European history, and the community is a melting pot of multiculturalism, with one in three people being born overseas and one in five speaking a language other than English at home.


The ideal location, significant history, diverse community and strong economy ensures a positive future for the City of Swan, full of opportunity.

The Courtyard Studio – formerly the Old Water Corporation Building –located in the historic Carnegie triangle, the Midland Courtyard Studio hosts the Midland Library's Artists in Residence and creative workshops. Equipped with high end recording equipment the space can be used for projects including recording: podcasts, music and voiceover.

The Courtyard Studio provides:

- Studio access from 9am to 5pm daily
- Reverse cycle air-conditioning
- Free Wi-Fi
- Proximity to train station and bus port
- Equipment including 2 trestles, 1 chair, washing machine, bar fridge, bin, kettle, microwave, cupboard, door wedge, dustpan and broom, full easel and table easel, podcast equipment, cameras and computers.

2.4 Delivery method

Responses must be uploaded to the City of Swan's website e-form listed on the website <u>https://www.swan.wa.gov.au/explore-and-do/arts-and-culture/artist-opportunities</u>

Responses delivered by hand or submitted by email or facsimile will not be accepted.

2.5 Lodgement of Response

Responses must be lodged by the Deadline. Responses that are not in the e-tendering facility at the Deadline will not be considered for evaluation.

PART 3 EVALUATION PROCESS

This is an Expression of Interest (EOI).

The EOI is the first stage of a two-stage process. Following the close of the EOI the Principal may proceed to the calling of Request for Quotations (RFQ).

The issuing of an EOI does not commit the Principal to proceeding with an RFQ.

Eligibility to participate in the RFQ will be restricted to Respondents who comply with the provisions of this EOI and who are accepted by the Principal to be placed on a pre-qualified shortlist.

The Response of an EOI does not commit the Principal to include any organisation on the shortlist in the event that the service proceeds.

The Response will be evaluated using information provided in your statements addressing the Evaluation Criteria and other relevant information.

PART 4 STATEMENT OF REQUIREMENTS

4.1 Project Background

- 4.1.1 The Courtyard Studio Creative Writing Residency is a new outcome-driven residency initiative in 2024, developed as an extension of the City of Swan's successful Artist in Residence program.
- 4.1.2 The City has delivered an Artist in Residence Program since 2021 to assist in the activation of unused project spaces within several of the City of Swan's six (6) Community Libraries. Through this program the City hosted numerous guest artists, providing free temporary studio space and support for research, development and creative production. In this mutually beneficial arrangement, creatives in turn showcase their artwork and skills to the hundreds of community members who attend the libraries each week. This program has enabled the integration of artist-led workshops and studio open days into the City's diverse calendar of library programs.
- 4.1.3 In 2024, the City is looking to incentivise and support the production of new creative works in and about Midland.

4.2 Scope of Works

- 4.2.1 The City will select six (6) creatives to participate in the Courtyard Studio Creative Writing Residency, with each having access to the Courtyard Studio for two (2) consecutive months between 1 January – 31 December 2024.
- 4.2.2 The City welcomes applications from all including marginalised and underrepresented groups and individuals and sets out to create safe spaces, accessibility for all creatives.
- 4.2.3 In these two months, it is expected each creative will utilise this free studio space to support the research, development and creative production of new work for a minimum twelve (12) hours per week. During this time it expected the creatives will be receptive to community visitors for at least one day per week.
- 4.2.4 As host of the residency, the City will provide:
 - a) Orientation, housekeeping information, staff and emergency contacts
 - b) Workplace health and safety resources
 - c) Introductions to key contacts with the community
 - d) Administration, marketing and promotion of residency and programs
- 4.2.5 During the two month residency, creatives will be required to facilitate four (4) community programs to ensure there is opportunity for community collaboration and conversation. Programs may include, but are not limited to, skills development workshops, author talks, demonstrations, performances and other events. Content of programs will be determined in conversation between the creative and the project officer.

- 4.2.6 Within 6 weeks of the conclusion of the two month residency, the creative will be required to produce one piece of creative writing inspired by their experience of Midland. This work can be completed in any medium including but not limited to: song lyrics, a short story, a play, a poem or a text-based artwork.
- 4.2.7 While the content of this work should be reflective of Midland, there is no preference for the work's genre. As this residency takes place on Whadjuk land and keeping with the City of Swan's Policy of 'One City, Diverse Places' we encourage all creatives to make sure their work is inclusive and reflective of the Midland community.
- 4.2.8 The commissioned work will be collated and published alongside peer outcomes of the Courtyard Studio Creative Writing Residency in 2025.

4.3 Project Budget

- 4.3.1 Creatives selected for this residency are to receive a lump sum of \$2,400 inclusive of the creative writing commission fee of \$800 and community programs fee of \$1,600.
- 4.3.2 The commission fee is inclusive of the time of the creative in the creation of a new and unique work in response to their time in Midland. This fee also includes meeting attendance and any necessary materials.
- 4.3.3 The community programs fee is inclusive of preparation time and includes creatives' intellectual property.

4.4 Business structure

- 4.4.1 When the Principal makes payments to suppliers for goods or services to the business, those suppliers generally need to quote an Australian business number (ABN).
- 4.4.2 Certain suppliers are not required to quote an ABN to the Principal. In these cases, the suppliers can use the form Statement by a supplier. 4.5 Evaluation Criteria

- 4.5.1 As part of the Response to this Expression of Interest, Respondents must provide evidence of their experience and capabilities in a statement addressing the following essential Requirements as part of addressing the Evaluation Criteria.
- 4.5.2 Expressions of Interest shall be assessed against the following criteria:
 - (a) Demonstrated experience in undertaking previous works of a similar nature and quality.
 - (b) Demonstrate relevancy of artwork proposal to the Swan region.
 - (c) Demonstrate your ability to engage with the City of Swan by providing your governance and/or business structure.

- 4.5.3 Each Respondent is asked to provide the following in their Response (no more than 2 pages) as evidence to meet the criteria listed within 4.5.2:
 - a) Introduction of the creative practitioner and their field of work
 - b) Confirmation of their interest in participating in the residency.
 - c) Statement explaining how the residency will benefit the creative's career at this time.
 - d) Creative's availability in the 2024 calendar year to undertake the residency.
 - e) Brief descriptions of the proposed four workshops which the creative will facilitate during the residency.
 - f) Answer the following questions:
 - I. Do you have an ABN?
 - II. If you have no ABN, do you meet the eligibility criteria to complete a Statement by supplier form (see clause 4.4.2)?
 - III. Do you or your business hold any public or product liability insurance? (Please note: Answering 'No' to this question does not affect your eligibility to respond to this EOI)?
 - g) Supply examples of up to five (5) previously completed creative works. These may be submitted as links, or attachments such as: sound clips, documents or images. This is not included in previously mentioned page limit.
 - h) Submission should include the creatives Curriculum vitae (no more than 2 pages).
