Chairperson's Report

The COVID-19 pandemic continues to have a significant impact on the arts sector and young people in Western Australia.

In the face of uncertainty and instability, there has never been a more important time for connection, community, and creativity. This report demonstrates the agility, resilience and dedication of our staff, our stakeholders, our funding partners, our interns, our volunteers, our Board and our community to ensure our organisation can continue to support the changing needs of young people in the arts. It is my honour and privilege to have taken on the role of Chair at Propel this year, and to be opening our 2021 Annual Report.

2021 was a fantastic year for Propel's broad suite of programs. Our flagship program KickstART ran with a combined physical and digital presence in April, with highlights including the All Ages Drag Show at the State Theatre Centre, the KickstART Amphitheatre Closing Party in the Perth Cultural Centre, and the successful launch of a new visual arts mentorship program for BIPOC individuals in partnership with The Lester Prize. Our 2020 KickstART team celebrated their incredible efforts delivering the 2020 KickstART: Virtual Program at the WA Performing Arts Awards, bringing home the gong for most outstanding digital engagement program during COVID-19.

In acknowledgement of the changing needs of the youth arts community, Propel delivered the brand-new program PIVOT in October 2021. PIVOT was created to build the capacity of the sector by providing accessible support for young artists and arts workers to develop their career capabilities and administration skills. The pilot weekend symposium for PIVOT was delivered with the support of Lotterywest and was a successful program that will grow in 2022.

Last year also saw the continued development of Kadjin, a community-led program providing mentorship, a community

network, cultural learning, and individualised professional development support for a group of 60 and growing Aboriginal and Torres Strait Islander youth artists. Kadjin was also the focus of a grassroots fundraising campaign throughout 2020 and 2021, culminating in over \$23,000 in donations from our community. This amount was matched in funding through Creative Partnerships Australia with further support from Lotterywest, generating over \$60,000 in total to ensure Kadjin can continue into 2022 and beyond.

We rounded out the year with some more familiar faces, delivering projects like MOSAIC, Sketchbook, Contemporary Music: Youth Boost, as well as our Drug Aware YCulture Metro youth arts grants program, which provided a total of \$48,000 to a range of new projects thanks to our ongoing partnership with Healthway - now in its (sweet) 16th year.

Propel would not be the organisation you know without a foundation of good governance, strong financial management, and ongoing funding support. These areas are often 'unseen' and conducted behind the scenes, but the critical dedication of our staff, Board, sponsors, funding partners, and program partners ensures Propel continues to support its community with tailored programs and projects every year.

I would like to extend my immense gratitude for the commitment and hard work of our staff, Board, interns, and volunteers - particularly long-term staff and Board members who have moved on to exciting new opportunities this year, including Cecile, Yoshika, Karen, Aidan, and Rez. A special thanks must go to our outgoing Chair, Wanjie Song, for the incredible leadership and dedication she has given to Propel for the past 6 years on the Board.

Thank you to all who have engaged with Propel in some way over the past year – big or small. Your continued support for this organisation makes a meaningful contribution to our shared vision for Western Australia to be a place where creative potential is supported for all young people. I am excited to see what 2022 will bring.



General Manager's Report

One may be tempted to think of 2021 as a year in which our communities "bounced back" from the immense challenges we all faced during 2020. Unfortunately, it's not that simple.

While it is true that many arts activities were able to proceed during the year - including the bulk of our own programs at Propel - we cannot ignore the effects of mass bushfires, snap COVID lockdowns, and the many other significant events from the rollercoaster year that was 2021. The resulting burnout we all continue to feel is real.

Between 2020 and 2021, Propel has pivoted and adapted to new ways of working. Operationally, we have prepared ourselves for the realities of remote work for staff and introduced a new Employee Assistance Program to help support the social and psychological wellbeing of our team. From a governance standpoint, we have been holding online and hybrid board meetings since the start of the pandemic, including two consecutive Annual General Meetings being held online.

Our programs have been adapted to allow for greater flexibility and online access. For instance, the 2021 KickstART Festival retained a significant online component within its programming, after the success of 2020's KickstART Virtual. Additionally, towards the end of the year Propel piloted a new initiative called Pivot, which was created after conducting a needs assessment in consultation with emerging artists and arts workers throughout WA.

Maintaining such a high output level is hard work at the best of times, but we are not exactly living in the best of times. And while these times remain so uncertain and unprecedented, I am eternally grateful to be weathering the ongoing storm with such a compassionate and dedicated team.

Farewell and thank you to our outgoing staff members Cecile Vuaillat, Yoshika Kon, and Karen Connolly. These three individuals have been instrumental in helping Propel become the organisation it is today, and I doubt we would have achieved all we have over the past few years without them. I extend this gratitude to Zal Kanga and Kobi Arthur Morrison, who are continuing their important work with Kadjin and other community initiatives into the foreseeable future.

I like to thank our outgoing Board members Wanjie Song, Aidan Gordon, and Renee Zaffino-Little for their tremendous support throughout their respective tenures with Propel. I believe the governance of this organisation is in solid hands with Darcy Nidd as our new Chairperson and the recent additions of Monica Brierley-Hay, Emilee Rippon, and Yvette Henderson to the Propel Board.

This year we have welcomed several new staff members who have each already excelled within just a few short months at Propel: Phoebe Tan, Rebecca Riggs-Bennett, and Joanna Hiu. I also feel fortunate to be working alongside Noemie Huttner-Koros, Georgia Siciliano, and Esté Breytenbach in preparing for the 2022 KickstART Festival. There is certainly no shortage of enthusiastic and energetic young people helping to forge our future pathways.

Lastly, I thank our funding bodies and sponsors at the Department of Local Government, Sport and Cultural Industries, Healthway, the Department of Communities, Lotterywest, Creative Partnerships Australia, and the City of Perth, for continuing to support and believe in the work we are doing at Propel.

With Propel adapting in many ways, this seasonal cycle has been one of setting up new foundations.

With Propel adapting in many ways, this seasonal cycle has been one of setting up new foundations. Through the challenges of COVID and internal staff changes, the team has come together and offered what they can with a sense of care.

Throughout the year, we have implemented culturally backed practices into what we do at Propel, which is expressed through this artwork by Marli Ryan. The artwork shows the unity of beings from love, connecting through art, embedded in the land.

In 2021, Kadin members and members of the Propel team have had access to: cultural and holistic wellbeing training with Wisdom In Your Life; our second Trip onto Country with Elder Dr. Noel Nannup OAM; Propel's first Smoking Ceremony with cultural leader Shaun Nannup; and the further development of our Reconciliation Action Plan (RAP). Kadjin members have also gained knowledge on totems, skin groups, family connections, business development, self and artistic growth, and group development from leading Elders and professionals.

A key project this year was the development of our Cultural Calendar, designed for the continued wellbeing of Propel, staff, board, and members. The calendar includes:

- 7 An annual Trip onto Country with a local Elder, for holistic cultural, wellbeing, and location-based training
- Two daytrips for holistic cultural teachings with an Elder
- Continuation of training with Wisdom In Your Life, twice per year
- Annual Smoking Ceremony and Welcome to Country

These events are connected and follow the six-season cycle, led by Elders with personal connections to Propel. The cultural framework we have in place offers people at any level an opportunity to connect into the flow and learn cultural understandings. In this way, Propel can foster and hold new members and continue onwards with our unified growth with no one left behind. This is of importance to the wellbeing of Propel as an entity.

This cultural framework is created in stillness and held in the artworks, the experience, the cycle of events, the connections, the stories, and the relations between the people, not by any one person or ruling - it is a knowing that is led by eldership and land which provides us momentum and a way through challenges.

The feedback from these trips, trainings, and ways of being has been immense. Some have connected with family, learned their totems, pursued job opportunities, realised a sense of self or identity, challenged their unconscious biases, and stepped toward creating reconciliation and unity.

I have been supported to attend professional development which includes high-level cultural training of leadership practices and cultural knowledge integrating ancient ways of being with modern ways of being, these teachings are reflected in the programs and planning.

I look forward to continuing to develop our cultural calendar, growth of people of Propel's cultural understandings, our leadership, our relationships with Elders, our Kadjin members' growth, and our integration of strategic cultural practices based on unity through art.

YOUTH WEEK WA KICKSTART FESTIVAL



Youth Week WA KickstART Festival

The 2021 Youth Week WA KickstART Festival was a week-long state-wide celebration of young people that took place from 9 - 16 April. In total, 55 free events were held across the 8-day festival, including performances, exhibitions, workshops, talks, markets, special events, mentorships, and online activities.

In its 11th year, KickstART has grown into a large-scale youth festival that offers young people in WA – primarily aged between 12 and 26 – free opportunities to be creative, develop their skills, showcase their work to the community, and find out about the arts organisations, cultural institutions, and service providers available to them.

Programming for the KickstART Festival is developed and presented by Propel Youth Arts WA in direct consultation with young people. Content for KickstART 2021 was put together in collaboration with the Youth Week WA Planning Committee, which consists of 10 young people who were each paid a stipend for their time and contributions to this year's program.

117 artists were contracted during the course of KickstART 2021, with the majority of them being young and emerging (i.e. within the first 5 years of their careers) and 47 volunteers were also engaged throughout the Festival. Over 15,000 young people participated in KickstART in 2021.

The 2021 Youth Week WA KickstART Festival was made possible with support from the Government of Western Australia through the Department of Communities and the Department of Local Government, Sport and Cultural Industries. KickstART was also sponsored by Lotterywest and the City of Perth.

WORKSHOPS

18 capacity building workshops were held during KickstART 2021, covering a diverse range of topics including astrophotography, collage, creative writing, drag performance, hip-hop dancing, illustration, meditation, and sexual health.


Workshop highlights this year included a special Noongar hip-hop workshop facilitated by Flewnt at the Dungeon Youth Centre in Ballajura, and the Introduction to Urban Sketching walkabout workshop with local artist Ryan Ng.

TALKS

7 youth-led conversations were held during KickstART 2021, including opportunities for the transferral of ancient cultural knowledge, change-making with intersectional voices at the forefront, and a series of mental health workshops presented in partnership with headspace.

Youth Week WA 2021 Ambassador Zahra Al Hilaly led and facilitated a group discussion featuring a panel of young leaders from migrant and refugee backgrounds, to discuss their path in creating a safe culture for all intersectional voices within arts and advocacy circles.





PERFORMANCES

KickstART 2021 played host to Western Australia's first ever all-ages drag show, hosted by Justin Sider and featuring young participants of the Drag Kingdom workshop series held earlier during the Festival. This event was attended by 113 people in the Rehearsal Room at the State Theatre Centre of WA.

KickstART Market Day on Saturday 10 April featured live music performances from Siobhan Cotchin, Muscle Club, Claudie Joy & The Joy Boys, and Noah Dillon. Since 2011 this event has been held in the Perth Cultural Centre in Northbridge but in 2021 Propel trialled the event in Forrest Place, in order to increase our reach to young people who do not visit Northbridge regularly. Over 13,000 people attended Festival Day in 2021.

Lastly, the Amphitheatre Closing Party on Friday 16 April featured live performances from Sofa, Smol Fish, Alter Boy, Adrian Dzvuke, and Jack Davies & The Bush Chooks, and was attended by over 800 young people at the Perth Cultural Centre.

SPECIAL EVENTS

From the continuation of Propel's long-running Sketchbook Project Exhibition, to the second year of the KickstART Virtual Market, there were 7 special events held during KickstART that helped showcase the incredible young work that young people are doing in our communities.

The Youth Arts Mingle Night + Photography Exhibition at The Art Garage in Mt Hawthorn provided a platform for young photographers to display their work to their peers, and for connections to be made within the local emerging arts community.

Kadjin took over the exhibition space at PICA for an all-day Yarning Circle, a drop-in event for young people to gather, share, and connect with others and themselves through art.

MENTORSHIPS

Propel partnered with The Lester Prize to deliver a two-day intensive mentorship for 16 young artists from diverse backgrounds, to help them to develop their art practice in drawing, print making and painting. Sessions during the intensive were led by established professional artists such as Andy Quilty, Mark Tweedle and Camilla Loveridge, and the lead mentor for the project was Thrown Waigana, a proud Wandandi Noongar (Aboriginal) and Art Koedhal (Torres Strait Islander) artist.

Additionally, Propel worked with local writer and educator Maddie Godfrey to deliver the Mapping Your Moments online writing mentorship, where participants met for four online workshops throughout March 2021, and had their works published in an online zine published during KickstART this year.





Drug Aware YCulture Metro





Drug Aware YCulture Metro is an ongoing grants program providing young and emerging Western Australian artists with funding for new arts projects and initiatives.

In 2021, Propel added value to its long-standing partnership with Healthway by increasing the funding amount from \$3,000 to \$4,000 per project.

15 applications were made to the YCulture Metro program in 2021, 12 of which were approved for funding. Incredibly, all of the 12 successful grant recipients this year were first-time applicants to the program!

Although the initial arrival of the pandemic affected the allocation of all 16 grants in 2020, 2021 has bounced back with funded applicants pursuing ambitious and innovative concepts that engage young people, participants, and audiences in considered ways.

Community engagement, multi-disciplinary collaboration, and opportunities for young people to be showcased are across all 12 of the funded projects for this year, demonstrating the drive for social, sustainable, and positive creative engagement in an uncertain time.

Projects supported by YCulture Metro in 2021 included over 23 events featuring 570 direct participants, 3,500+ indirect participants (such as audience and attendees), and had an extended reach of 33,100+ people online and via social media, to whom the Drug Aware message was promoted.

This project by Murdoch Medieval Club (MMC) was a youth-driven series of medieval artistic programs that pursued events on campus after the cancellation of Swan Valley Medieval Fayre, which they were originally included in. A variety of creative skills were offered to young people through workshops at Murdoch, and the project focused on cultural and social outcomes with consideration on accessibility, safety, inclusivity and amplified young voices to create a sense of belonging for participants.

12. DRUG AWARE: THE W'AFRICA PROJECT



Youth Boost

Contemporary Music: Youth Boost

The Contemporary Music Fund: Youth Boost program arrived during a time of unprecedented uncertainty within our community, as there were significant restrictions placed on running public events due to the first wave of COVID-19.

This impacted the delivery of All Ages concerts that had previously been arranged with various Local Government Authorities across the Perth Metropolitan Area between 2020 and 2021.

With the surplus for the first year of activities carried forward into 2021, Propel established broader community partnerships with local artists, youth organisations, and commercial initiatives. This was in addition to the additional music programming for KickstART 2021.

Fortunately, all in-person activities that had been planned for 2021 went ahead without cancellation, which resulted in a total of 17 live music events delivered throughout year two. These events engaged a combined total of 114 young music artists in paid roles and were enjoyed by a combined audience of 10,397 people.

HIGHLIGHTS FROM 2021:

PERTH MAKERS MARKET AND MIRRABOOKA COMMUNITY MARKETS

Propel partnered with Perth Makers Market to provide paid performance opportunities for emerging solo and duo musical acts to perform sets at five market events in Goolugatup Heathcote and Yagan Square. Propel also continued its partnership from with MercyCare, the City of Stirling, and The Square Mirrabooka to deliver music performances from young people as part of the Mirrabooka Community Markets.

WA YOUTH AWARDS

Long-time Propel partner YACWA (Youth Affairs Council of WA) presents the WA Youth Awards each year, however the 2020 awards were cancelled due to COVID-19. In 2021, Propel partnered with YACWA to provide musical entertainment as part of the proceedings, providing four performances by young musicians taking place at the event, which was held at WA Museum - Boola Bardip in front of over 300 people.

TEA AND SYMPHONY

Snart Club, a local youth arts collective led by emerging arts manager Anastasia Beasley, approached Propel to collaborate on a music event that would embrace cosiness and slowness, rather than speed and loudness. Presented in the PICA Performance Space, Tea and Symphony was presented as a drop-in afternoon of live music performances, collaborative jam sessions, and cups of tea for all.

PROJECT 54

Presented by Soul Alphabet in collaboration with Propel, Project 54 was a multidisciplinary collective body of work that navigates the past, present and visions of the future of Afrikan music and it will also be paying tribute to Afrika as the birthplace of the many musical genres we hear today. 20 CaLD-identifying local artists and arts workers received paid work through this project, which attracted 200+ attendees during the project residency at Cool Change Contemporary.






Pivot: Arts admin for sustainable careers is a new program presented by Propel Youth Arts WA aiming to build capacity among young and emerging artists and arts workers in Western Australia to make their careers sustainable and commercially viable.

In 2021, Propel received Lotterywest support to trial the Pivot project, which resulted in a weekend symposium at the Art Gallery of WA and State Library of WA between 2 – 3 October 2021. The Pivot Symposium featured 6 in-person workshops covering the basics of arts marketing, law, mental health, workers' rights, finance, and grant-writing.

During the weekend, Propel also offered in-kind resume assistance and headshot photoshoots to participants who registered in advance. We closed the weekend with an informal sundowner, which provided participants with an opportunity to network with local arts and community leaders, and with each other. Over 230 people attended the Pivot Symposium.

For the remainder of October, Propel partnered with Creative Plus Business to deliver a weekly series of free online workshops focusing on topics related to freelance arts work, time management, and diversifying creative income.

We look forward to growing upon the Pivot project in 2022 and beyond, so watch this space!

The financial report is a special purpose financial report that has been prepared in order to satisfy the financial reporting requirements of the Propel Youth Arts WA constitution, Associations Incorporations Act 2015 and the ACNC Act 2012. The Executive Committee has determined that the association is not a reporting entity.

There is an ongoing sublease for office space with PACS Inc (t/a The Blue Room Theatre). The agreement was signed can terminate the lease on 3 months' notice at any time. Therefore, the lease is termed a month-to-month lease.

Although Propel Youth Arts WA has adopted AASB 16 from 1 July 2019 which requires right-of-use assets and corresponding lease liabilities to be recognised in the statement of financial position, as the lease in place falls within the exemption provided for in AASB 16 regarding short-term leases and leases of low-value assets, AASB 16 has not been applied.

Basis of preparation

The financial statements have been prepared on the accrual basis of accounting using the historical cost convention.

The financial statements are presented in Australian dollars and all values are rounded to the nearest dollar.

a) CASH AND CASH EQUIVALENTS

Cash and cash equivalents include cash on hand and deposits held at bank.

b) PROPERTY, PLANT AND EQUIPMENT
